- 2. In case the college is already having affiliation to B.A./B.Sc./B.Com. & College applies for fresh affiliation to any new/additional optional subject of the course concerned, then the fee shown at Sr. and a would be charged extra per optional subject only at the time of fresh affiliation to the optional subject.
- 3. In case the college applies for permanent affiliation to any course/subject, it shall pay four times of the fee prescribed for extension in provisional affiliation to the course/subject concerned.
- 4. An amount of Rs. 20,000/- / Rs. 40,000/- towards inspection fee for obtaining fresh/extension in provisional/permanent affiliation to each course/subject shall be payable as inspection fee. However inspection fee in case of Sr. No. 4 will also be payable @ Rs. 20,000/- per additional subject.

Explanation: - For the purpose of charging inspection fee at M.A./M.Sc./M.Com. Level, one subject would be treated as one course.

5. However, in case of extension in provisional affiliation to the additional 1/2/3 unit/intake in B.Ed. course in college, the inspection fee shall be payable Rs. 20,000/- against the extension in affiliation to all already affiliated units in a college.
