विशय:- स्नातक पाठ्यक्रमों में ऑनलाइन प्रवेश प्रक्रिया उपरान्त रिक्त स्थानों पर सत्र 2020-21 में सीधे प्रवेश प्रक्रिया के दिशा-निर्देशों की सूचना हेतु।

महोदय/महोदया,

उपरोक्त विषयान्तर्गत लेख है विश्वविद्यालय परिसर में संचालित विभिन्न स्नातक पाठ्यक्रमों में रिक्त स्थानों पर सीधे प्रवेश (Direct Admission) हेतु दिशा-निर्देश निम्न है-

1. विभिन्न स्नातक स्तर के पाठ्यक्रमों में सूची अनुसार रिक्त स्थानों पर छात्रों को सीधे प्रवेश दिये जाने की प्रक्रिया दिनांक 07/12/2020 से 15/12/2020 के मध्य संचालित की जा रही हैं।
2. इस प्रवेश प्रक्रिया में भाग लेने के इच्छुक एवं निर्धारित पात्रताधारी योग्य अभ्यर्थी द्वारा ऑफलाईन आवेदन शुल्क रु. 500/- तथा निर्धारित प्रवेश शुल्क/पाठ्यक्रम शुल्क के दो अलग-अलग डी.डी. बनवाकर भरे हुए आवेदन-पत्र के साथ संबंधित विभाग में जमा करवाने होंगे।
3. विभिन्न पाठ्यक्रमों में प्रवेश हेतु विश्वविद्यालय नियमानुसार निर्धारित पात्रता पूरा करने पर ही किसी अभ्यर्थी को प्रवेश दिया जा सकेगा। यद्यपि स्नातक पाठ्यक्रमों में प्रवेश हेतु पूर्व निर्धारित पात्रता परीक्षा प्रतिशत में 3 प्रतिशत की छूट दी जा सकेगी। (प्रवेश नीति के बिन्दु सं. 4.23 के अनुसार)।
4. विश्वविद्यालय की प्रवेश नीति के अनुसार निर्धारित अर्हताधारी योग्य अभ्यर्थियों को आवेदन पत्र के साथ पाठ्यक्रम शुल्क, स्थानीय निधि शुल्क व कॉशन मनी की राशि का डी.डी. जो कि कुलसचिव, कोटा विश्वविद्यालय, कोटा के नाम देय हो, संलग्न करना होगा।
5. दिनांक 15/12/2020 को कार्यालय समय तक प्राप्त आवेदन पत्रों की जांच सम्बंधित विभाग के स्तर पर की जाकर मेरिट के आधार पर निर्धारित पात्रताधारी एवं पूर्ण आवेदन प्रस्तुत करने वाले अभ्यर्थियों की सूची तैयार की जावेगी तथा सफल अभ्यर्थियों की सूची का प्रकाशन किया जाकर दिनांक 16/12/2020 को विभाग के सूचना पट्ट पर सूची प्रदर्शित की जावेगी।
6. इस प्रवेश प्रक्रिया में आरक्षित वर्ग के रिक्त स्थानों पर सामान्य वर्ग के निर्धारित अर्हता धारक अभ्यर्थियों को भी प्रवेश दिया जा सकेगा तथा सामान्य वर्ग के रिक्त स्थानों पर सभी वर्गों के केवल उन्हीं अभ्यर्थियों को प्रवेश दिया जा सकेगा जो कि सामान्य वर्ग के लिए निर्धारित अर्हता पूरी करते हों।
