M. Phil examination of Sociology shall consist the following :

- (a) Two Compulsory Paper  
Paper I - Advanced Sociological Theory  
Paper II - Advanced Research Methodology
- (b) Third paper will consist two alternative Papers and the Candidate will be required to opt any one of them:  
Paper III (A) Social Change and Modernization  
Paper III (B) Indian Society: Structure and Processes
- (c) Paper IV will be Dissertation about 100 – 125 pages on a subject related to the candidate major field of study. It will include a bibliography and critical review of existing literature on the subject. The dissertation may be based on primary data collected by the candidate, may be based on secondary data or on a problem for which some solution may be projected or on the application of some methodology for the purpose of testing any hypothesis through Secondary data. The faculty members having Research degrees (Post Doctoral / Doctoral) will be able to supervise candidates for dissertation. The dissertation should essentially be forwarded through course co-ordinator / Head of Department.

### Scheme of Examination:

The M. Phil course in Sociology will be Research based and it will be for the full time Regular student in the discipline of Sociology with differing emphasis on Papers, training in Research Methodology and Dissertation writing.

The students are required to offer three written papers and on dissertation (equivalent to one paper). Each Theory paper shall consist of 100 marks out of which 80 marks shall be for External assessment and 20 marks for internal assessment. The internal assessment shall be based on class test / term papers/ Seminars / and class performance or a combination of these methods. The dissertation shall also consist of 100 marks. Five copies of dissertation shall be submitted by the candidates atleast three weeks before beginning of theory examination.
