The Interested bidders may submit their on-line bids along with separate Demand Drafts drawn in favour of "Registrar, University of Kota, Kota" payable at Kota towards the cost of Tender Fee (non-refundable) and RISL Processing Fee (Non-refundable) demand draft shall be in favour of "Managing Director, RISL" payable at Jaipur.

Bid shall be accompanied by a bid security declaration in lieu of Bid security in prescribed format on the Judicial Stamp of Rs. 50/- (with 30% surcharge payable) (applicable up to 31/12/2021, as per the Rajasthan Transparency in Public Procurement (Second Amendment) Rules, 2020 Finance (G&T) Department Notification published in Rajasthan Gazette Extraordinary on 18 December 2020).
4. The above mentioned demand drafts and the Bid Security declaration must reach physically in the office of Procurement Entity, University of Kota, Kota on or before last date & time as mentioned above failing which bids shall not be considered.

Bidders, having digital signature certificate (DSC) as per IT Act, 2000 to sign their electronic Bids, shall submit their offer online on www.eproc.rajasthan.gov.in within stipulated time and date mentioned herein above. Bids shall not be accepted personally. The Bids will be opened on the same date and time before purchase committee in the presence of bidder or their authorized representative whosoever may be present.
